Did you know. . . the following Supra functions can be performed within the MLS?



-  Assign Supra Keybox
-  Supra Activity Report
-  Keybox Settings

Here's how. . .

1. From the SEARCH menu in the MLS, select INVENTORY
 2. Select RESIDENTIAL (category) - ACTIVE (status), click ACCEPT at the bottom right of the page
 3. Your RESIDENTIAL/ACTIVE listings will be displayed. Select the listing in which you want to attach the Keybox
 4. Click the "S" link at the far right of the line list
 5. From the menu (as shown above), select Assign Supra Keybox
 6. Enter the Keybox serial number and shackle code, click SAVE
- Your Keybox is now assigned. Once accomplished, you can check the activity and even change the Keybox settings - all through the MLS.
